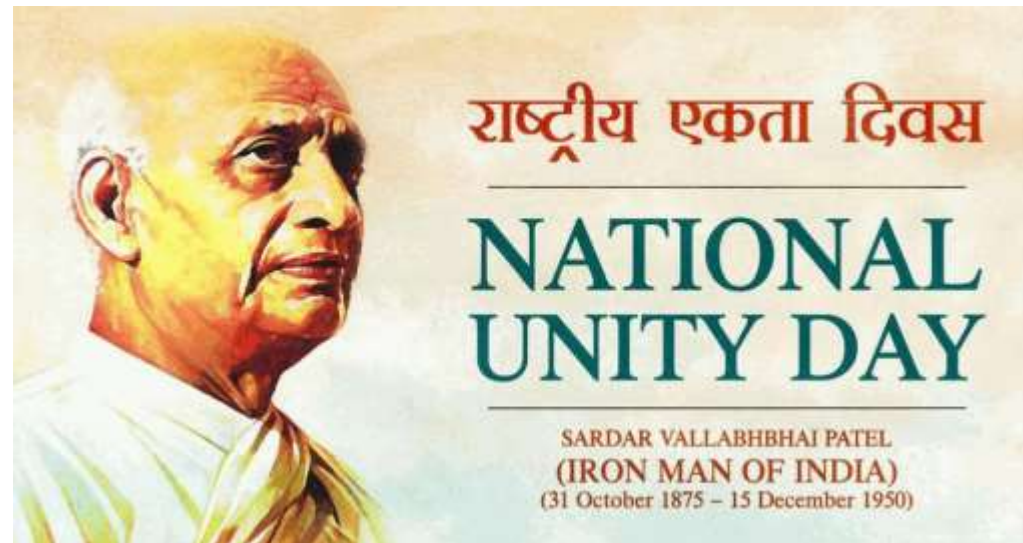

3. Australian great Alan Davidson passes away at 92

- Australian **legend Alan Davidson** has passed away at the age of 92.
- The bowling allrounder, who made his **Test debut against England** in 1953, represented Australia 44 times in the longest format.
- The left-arm pacer had finished his career with a stunning average of 20.53, having picked up 186 wickets. His career-best figures of 7/93 came against India in 1959.
- Davidson was a handy batsman, registering five vital half-centuries in his career, including the 80 he hit in the first ever tied Test match in 1960 against West Indies. In the same game, he had also picked up 11 wickets.

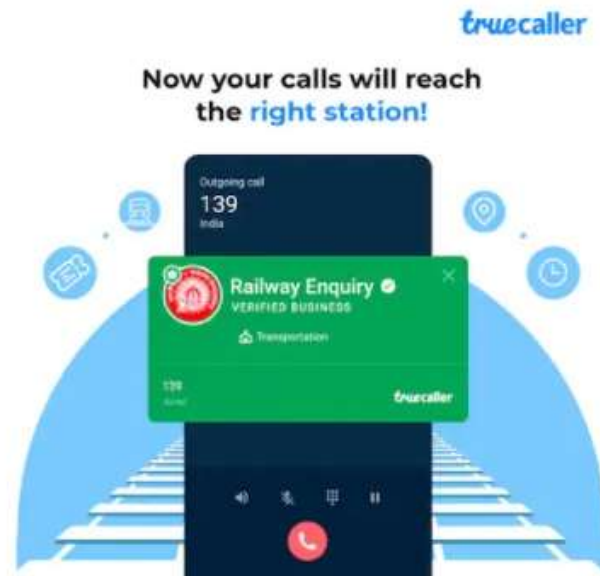
