According to the minister, the IVF mobile van was "dedicated in a joint venture of the Government of India and Amar Dairy."

This is India's first IVF mobile unit. With the help of this unit, the work of providing IVF technology to the cattle rearers of Amreli has started.



Notably, IVF is a complex series of procedures used to help with fertility and assist with the conception of a child. In animals, it is an advanced reproductive technology for the multiplication of superior female germplasm at a higher rate.

Tripura government has signed an agreement for an ADB-assisted project of Rs 2,275 crore (US \$275 million) for the Improvement of Tripura's Power Distribution Strengthening and Generation Efficiency.

The project would have an Rs 1820 crore loan from ADB and Rs 455 crore of direct investment by the State government to improve energy security, quality of supply, efficiency, and resilience of the power sector in Tripura.

Deputy CM said detailing that the existing 63 MW (3X21 MW) Open Cycle power project with a 120 MW Combined Cycle power project in Rukhia in Sepahijala district would reduce

greenhouse gas emissions after the improvement of the generation infrastructure. The State government is implementing result-based reform linked RDSS Scheme to improve the operational and financial viability of the Corporation at an investment of Rs 800 Cr. Under this Scheme, 5.47 lakh Smart and Prepaid Meters would be installed on Consumer premises. In addition, 8720 km LT Aerial Bunched (AB) Cable and 830 Distribution Transformers (DTs) would also be installed. The efficiency of the Gomti Hydel Power Project would be increased through its modernization.

A Government Order (GO) was issued by the Environment, Climate Change and Forests Department in line with the announcement made in the State budget.



The TNGCF will support various Climate Change initiatives, mitigation, and greening projects.

The fund will mobilize necessary resources from Government, development finance institutions, international climate funds, etc. It will be managed by the Tamil Nadu Infrastructure Fund Management Corporation (TNIFMC) Limited with a fund size of Rs 1,000 crore with a greenshoe option for another Rs 1000 crore.

This fund is to be set up as a Category I (Social Venture Fund) under the SEBI Alternative Investment Fund Regulations, 2012.

Market regulator SEBI has levied a penalty of ₹1 lakh each on DSP Investment Managers and DSP Trustees for bearing the extra expense ratio of its DSP Nifty 50 ETF on its books.

DSP Mutual Fund in its compliance test report for the March quarter and Half Yearly Trustee Report ended March informed SEBI that the total expense as a percentage of the average

asset under management (AUM) was higher than the total expense ratio (TER) charged to the scheme (DSP Nifty 50 ETF); the excess expenses were borne by DSP Investment Managers. The reason for the AMC bearing the excess expenses is the competitive market. Increasing TER would have restricted the ability to increase the scheme's AUM.

The AMC has violated the SEBI circular which requires all scheme-related expenses to necessarily be paid from the scheme only within the regulatory limits and not from the books of the AMC, its associate, sponsor, trustee, or any other entity through any route.

rate slipped to 7.44 percent from 7.55 percent, the data showed.

The volume of transactions, too, rose by a sharp 7.1 percent to ₹783 crore during the month, according to data by NPCI (National Payments Corporation of India).

As a result, the UPI network ended 2022 with a growth of 90 percent in the volume of transactions and a 76 percent rise in the value of transactions over the year-ago period.

The network processed around 7,404 crore transactions worth ₹126-lakh crore compared with 3,800 crore transactions worth ₹72-lakh crore in 2021.

For FY23 so far, the network has seen 5,949 crore transactions worth ₹99.8-lakh crore. In comparison, UPI had processed 4,597 crore transactions amounting to ₹84-lakh crore in FY22.

On the other hand, data by NPCI showed that transactions via the AePS (Aadhar-enabled payments service) platform fell to ₹25,972 crores in December from ₹26,058 crores in the previous month, and also lower than ₹31,113 crores registered in October.

In terms of volume, the number of AePS transactions fell to a multi-month low of 9.5 crores from 9.6 crores in November and 11.8 crores in October.

Set up under the 'long-term directed research policy' of the Defence Ministry, the center will undertake basic and applied research in verticals like electronics and computational systems; naval systems and naval technologies; advanced combat vehicle technologies; high-power CW laser sources; and next-generation communication and networking technologies.

SPRINT Challenges was launched by PM Modi during Naval Innovation and Indigenisation
Organisation (NIIO) seminar 'Swavlamban' in
July 2022.

'SPRINT' stands for Supporting Pole-vaulting In R&D through Innovations for Defence Excellence (IdeX).

After the construction of the weaponized autonomous unmanned boat, the Indian Navy can order 12 systems.

Naval Innovation and Indigenisation
Organisation (NIIO): Defence Ministry launched
the NIIO in August 2020, to encourage
innovation and indigenization for self-reliance in
the defense sector. It is a 3-tiered organization.

Naval Technology Acceleration Council (N-TAC) will bring together the twin aspects of innovation and indigenization and provide apexlevel directives.

A working group under the N-TAC will implement the projects.

Launched in 2018, the ADP aims to quickly and effectively transform (socio-economic status of) 112 most under-developed districts across the country, with a vision of a New India by 2022. The focus is to improve India's ranking under the Human Development Index (HDI) and localize Sustainable Development Goals (SDGs), leading to the progress of the nation. NITI Aayog works closely with the respective line Ministries and various development partners to fast-track progress at the district level, ensuring inclusive growth for all, 'Sabka Saath Sabka Vikas'.

In her Budget (2022-23) speech, the Finance Minister announced the government's intention to launch the ABP.

The ABP will take the aspirational district model up to the block level and will enable holistic development in those areas that require added assistance.

The program will cover 500 districts across 31 states and UTs initially and over half of these blocks are in 6 states - Uttar Pradesh (68 blocks), Bihar (61), Madhya Pradesh (42), Jharkhand (34), Odisha (29) and West Bengal (29).

According to IAF, she will fly the Su-30 MKI in 'Veer Guardian' exercises to be held at Hyakuri Airbase in Japan from 12 to 26 January.

Chaturvedi was part of the first batch of three women fighter pilots commissioned into IAF in 2016, a year after the air force, in a landmark move, decided to induct women in the fighter stream. She is qualified in the MiG-21 Bison and the Sukhoi-30 fighter jets.

Earlier this week, the Indian Army for the first time deployed a woman officer, Captain Shiva Chouhan, at Siachen, the world's highest and coldest battleground.

Earlier the Army deployed its largest contingent of 27 women peacekeepers in Sudan's disputed region of Abyei, where they will provide relief and assistance to women and children, and perform security-related tasks in a challenging mission as part of the United Nations Interim Security Force (UNISFA). IAF and Indian Navy have allowed women officers to join their special forces units— the Garud Commando Force and Marine Commandos, respectively, to promote gender equality within their ranks, provided they meet the selection criteria.

Since 2017, the Jaga Mission and the Odisha Liveable Habitat Mission have been part of an innovative state-wide land titling and slumupgrading program which aims to drastically



improve living conditions and promote social equality for the urban poor.

Initiated in 1985, the annual World Habitat
Awards competition attracts projects which
provide an outstanding contribution to people's
living conditions in a variety of contexts.

Reserve Bank may also permit higher shareholding of promoters on a case-to-case basis.
