The government has hiked windfall profit tax levied on domestically-produced crude oil as well as on the export of diesel and ATF, in line with firming international oil prices.

The levy on crude oil produced by companies such as Oil and Natural Gas Corporation (ONGC) has been increased to Rs 5,050 per tonne from Rs 1,900 per tonne.

Crude oil pumped out of the ground and from below the seabed is refined and converted into fuels like petrol, diesel and aviation turbine fuel (ATF).

The government has also hiked the tax on export of diesel to Rs 7.5 per litre from Rs 5, and the same on overseas shipments of ATF to Rs 6 a litre from Rs 3.5 a litre.

The new tax rates came into effect from February 4. The levy on both domestic crude oil and fuel exports is now off the lows it had hit last month.

India first imposed windfall profit taxes on July 1, joining a growing number of nations that tax super normal profits of energy companies. 2. The Panel will also include nominees from NITI Aayog, Department of Commerce, the Department of Economic Affairs, the Department of Consumer Affairs, the Department for Promotion of Industry and Internal Trade (DPIIT), and the Ministry of Electronics and Information Technology (MEiTY).

The committee has also been tasked with studying the international practices on regulation in the field of digital markets. The Panel will be required to study other regulatory regimes, institutional mechanisms, and government policies regarding competition in digital markets.

Also the Panel has been tasked to study the practices of leading players/ systemically important digital intermediaries (SIDIs) which limit or have the potential to cause harm in digital markets.

The return of the "bid bonds" is a confirmation of Dhaka cancelling its plans to import the rice as part of its efforts to buy five lakh tonnes for its public distribution system.

Sheikh Hasina Wajed government decided to "suspend the process of buying over-priced rice" from the two agencies — NCCF (National Cooperative Consumers Federation of India Ltd) and Kendriya Bhandar — last weekend. The impact of the deal is being felt in the Indian domestic market with prices of parboiled rice dropping at least 10 per cent after having increased 30 per cent in January to ₹29,000 a tonne. Prices had surged on expectations of the G2G rice deals with Bangladesh going through.

Dhaka's plans to enter into G2G deals to import parboiled rice ran into rough weather after it face criticism of paying a higher price than what some private Indian exporters had

In December, NCCF and Kendriya Bhandar offered to supply the two lakh tonnes under G2G deals at \$433.60 and \$433.50 a tonne, respectively.

Technically, ChatGPT can be categorized as a type of generative AI - a broad label that's used to describe any type of artificial intelligence (AI) that can be used to create new text, images, video, audio, code or synthetic data.

Thus, ChatGPT is a complex machine learning model developed by OpenAI (a

research firm founded by Elon Musk), that can carry out natural language generation (NLG) tasks with a very high level of accuracy. Bard is Google's own conversational Al chatbot and is based on LaMDA. It draws on information from the web to provide fresh, high-quality responses. In short, it will give in-depth, conversational, and essay-style answers just like ChatGPT does right now.

Bard is built on Transformer technology which is also the backbone of ChatGPT and other AI bots.

Transformer technology, pioneered by Google and made open-source in 2017, is a neural network architecture, which is capable of making predictions based on inputs.

Chinese search giant Baidu has also announced that it plans to debut a ChatGPTstyle application in March called "Ernie." About ChatGPT:

Chat Generative Pre-training Transformer (ChatGPT) is a version of the GPT model trained from the internet with an enormous text dataset.

ChatGPT is developed by a San Franciscobased AI and research company, OpenAI, and the final version was launched on November 30, 2022.

It comes as Microsoft has invested \$10 billion this year in OpenAI and is preparing to -Announce an integration of ChatGPT into its Bing Search engine.

Unmanned traffic management systems will play a key role in how airspace will be managed, allowing multiple beyond visual lineof-sight (BVLOS) drone operations to be run by different firms at the same time. Globally, several companies, such as USbased AirMap and Netherlands-based Airbus, offer such solutions.

According to Ankit Kumar, chief executive officer of Skye Air, the software imports data from the government's Digital Sky platform, which has been created to help drone operators plan flights in Indian airspace.

About Skye Air:

The platform was first launched in 2018 and offers operators essential information for running drone missions in the country. It is run by the Directorate General of Civil Aviation (DGCA).

Skye UTM will allow operators a "better understanding" of where they can fly. India's Drone Rules 2021 set restrictions on where private entities can fly zones by designating red, green and yellow zones.

The TTC with India is the European Union's(EU's) 2nd such technology partnership after the 1st one with the United States(US) that was firmed up in June 2021. **Key Highlights :**

Under the TTC, 3 working groups have been established.

technologies; and trade, investment and resilient value chains

Indian birders have participated in the GBBC since the event went worldwide in 2013. India was among 190 countries that participated in GBBC 2023.

Kerala recorded the highest number of checklists of birds.

West Bengal reported 489 species, the most among the 35 participating States and Union Territories.

Uttarakhand, Arunachal Pradesh, Assam and Karnataka followed with 426, 407, 397 and 371 species respectively.

Tamil Nadu and Kerala took the eighth and ninth spots with 349 and 325 species. Pune birders uploaded more than 5,900 lists, the most among urban centres.

GBBC India is coordinated by the Bird Count India collective, a coming-together of a number of groups and organisations that are interested in birds, nature and conservation.

Cadaveric donation comprises organ donation i.e., taking organs (heart, lungs, kidneys, liver, pancreas) from brain-dead people, as well as tissue donation, meaning taking tissues (skin, corneas, tendons, bone) from brain dead as well as heart dead people.

Certain States like Kerala and Maharashtra have been charging fees ranging from ?5,000 to ?10,000 for registering organ transplant patients.

Previously, the Health Ministry has proposed a 'One Nation One Policy,' for organ donation and transplantation.

Government removes the need for domicile registration to receive organs from a particular state/union territory

All states/UTs directed to not charge any fee for organ recipient registration.

Patient will be now allotted a unique ID by NOTTO on registering which will get carried forward even if the patient changes multiple hospitals in different States. The number of organ transplants has increased by over three times from 4,990 in 2013 to 15,561 in 2022.

The most common organ transplant is for the kidney, followed by liver, heart, lung, pancreas, and small bowel transplants. India conducts the third highest number of transplants in the world, but the number of organs needed is still much higher than the number of transplants.
