The key feature of this initiative is the provision of a doorstep gold loan facility.

This means that customers can avail of gold loan services from the bank **without** having to **visit a physical branch**.

The bank's representatives will visit the customer's location to facilitate the gold loan process.

Initially, the 'KBL-Swarna Bandhu' product will be available to customers in select centres or branches of Karnataka Bank.

It will be gradually expanded to cover all branches of the bank.

2. Which bank recently had its banking license cancelled by the Reserve Bank of India (RBI) due to inadequate capital and non-compliance with banking regulations? (b) Nashik Zilla Girna Sahakari Bank Limited

# Answer: B

The **Reserve Bank of India (RBI)** has cancelled the **banking license** of **Nashik Zilla Girna Sahakari Bank Limited,** which is located in Nashik, Maharashtra.

It does not have adequate capital and earning prospects.

Additionally, the bank has failed to comply with the requirements of provisions of the **Banking Regulation Act, 1949.** 

As a result of the license cancellation, the bank is prohibited from conducting the business of 'banking' with immediate effect.

This includes accepting deposits and making repayments to depositors.

Depositors of the bank are eligible for deposit insurance coverage provided by the **Deposit Insurance and Credit Guarantee Corporation** (DICGC).

Each depositor is entitled to receive a deposit insurance claim amount of up to **Rs 5 lakh**.

According to the data submitted by the bank, a significant majority of depositors, specifically **99.92%**, are entitled to receive the full amount of their deposits from DICGC.

DICGC has already disbursed **Rs 16.27 crore** of the total insured deposits based on the

It consists of **8 cricket-based animation films aimed** at promoting gender parity, equipping girls with life skills, and encouraging their participation in sports.

The program was launched in collaboration with key organizations, including the International Cricket Council (ICC), United Nations Children's Fund (UNICEF), and the Board of Control for Cricket in India (BCCI).

CRIIIO 4 GOOD' is available in **3 languages: English, Hindi,** and **Gujarati,** making it accessible to a wider audience. The themes of the **8 modules** are: **leadership**, **problem-solving**, **confidence**, **decision-making**, **negotiation**, **empathy**, **teamwork** and **goal setting** and are visualized through state-of-theart animation using cricketing examples.

Smt. Smriti Mandhana shared the first learning modules of 'CRIIIO 4 GOOD' with over 1000 school children at the stadium.

The modules are designed to be highly engaging, using the power of cricket to convey essential life skills and promote gender equity among girls and boys in an interactive and enjoyable manner.

4. What is the byproduct produced by the nation's first green hydrogen-powered bus unveiled by the Indian Oil Corporation (IOC)?

Indian Oil Corporation (IOC), India's leading oil firm, has unveiled the nation's first green hydrogen-powered bus.

This bus **emits only water** as a byproduct, making it an environmentally friendly transportation solution.

IOC will produce approximately **75 kg of hydrogen** by using a process called electrolysis, which involves splitting water

using electricity generated from renewable sources.

The green hydrogen will be utilised to power two buses that will operate in the **National Capital Region (NCR).** 

The adoption of hydrogen as a fuel source aligns with India's efforts to transition away from fossil fuels and reduce environmental impact.

The Indian Oil Corporation Research and Development Center, located in Faridabad, is responsible for producing green hydrogen for this pilot run.

The buses will be equipped with four cylinders, each filled with **30 kg of hydrogen**.

These cylinders can be refilled in just 10-12 minutes, allowing for efficient and convenient operation.

Hydrogen as a fuel offers a **3-fold increase** in energy density compared to conventional fuels and does not emit harmful emissions, contributing to cleaner air quality.

The production of 1 kg of hydrogen requires 50 units of renewable electricity and 9 kg of deionized water.

India boasts one of the largest synchronous grids in the world, making it a suitable candidate for the integration of renewable hydrogen production.

Oil and gas Public Sector Undertakings (PSUs) in India are aiming to produce approximately **1 million tonnes per annum** of

green hydrogen by 2030, marking a significant shift toward sustainable energy sources.

5. Which country is actively seeking to rejoin the United Nations Human Rights Council (UNHRC) after being removed from the council in April 2022?

Russia is seeking to rejoin the United Nations Human Rights Council (UNHRC) after being removed from the council in April 2022.

Russia aims to rejoin the UNHRC with the belief that it will help restore its international credibility and potentially address allegations of human rights abuses associated with President Vladimir Putin's regime.

Russia was removed from the UNHRC in April 2022 due to **allegations of human rights violations** by Russian soldiers in Ukraine.

The motion to remove Russia was introduced by the **United States** and garnered **93 votes** in favour.

To remove a member from the UNHRC, a twothirds vote of the total members is required,

highlighting the significance of the decision to remove Russia.

A report by **Special Rapporteur Mariana Katzarova** detailed mass arbitrary arrests of critics of the war by Russian authorities, contributing to the concerns raised by the international community.

The dispute centres around the taxation of Dream11's revenue.

While Indian tax authorities are demanding a higher **28% tax** on the total gaming revenue received from players, Dream11 argues that it

should be taxed on the fees it charges its users.

The tax authorities have given Dream11 a **30-day window** to provide justifications for not paying the shortfall, which amounts to **2.1 billion rupees** (approximately \$26.07 million) for the fiscal year 2017–18 and 10 billion rupees (around \$120.85 million) for the fiscal year 2018–19.

Tax officials are also extending their examination to Dream11's tax payments for an additional four years, spanning up to March 2023.

In 2023, the Kerala-based private sector lender, Federal Bank, raised **₹959 crore** through a preferential issue of shares to a member of the World Bank Group.

He was commissioned into the Corps of Engineers in **1987**.

He has participated in several significant military operations, including **Operation Vijay**, **Operation Rakshak**, and **Operation Parakram**.

He has extensive experience serving in border areas, particularly in Ladakh, Arunachal Pradesh, and Jammu & Kashmir.

He has completed various professional military courses, including those at the Defence Services Staff College, Higher Command, and the National Defence College. Throughout his career, he held critical command positions such as the Command of **58 Engineer Regiment & 416 Engineer** 

Brigade.

His career includes appointments as Deputy Director General, Discipline and Vigilance at HQ of MoD (Army), Commandant of the Bengal Engineer Group & Centre in Roorkee, Chief Engineer Southern Command, and ADG at the Engineer-in-Chief Branch at IHQ of MoD (Army).

This marked a remarkable growth of 17.63 percent when compared to the ₹14.12 lakh crore collected in the preceding fiscal year.

This enables them to use the card for thoughtful gestures to customers, employees, or loved ones.

The government has maintained the interest rate on General Provident Fund (GPF) savings at 7.1% for the October-December quarter.

The Finance Ministry officially notified the interest rate, which is also applicable to other provident funds for government employees,

The returns on the popular Public Provident Fund (PPF) have remained unchanged at 7.1% since the first quarter of 2020-21.

The General Provident Fund (GPF) is a **longterm investment option** that allows government employees to accumulate savings over their employment tenure.

GPF is a **mandatory scheme** for government employees, requiring them to contribute a certain percentage of their salary towards the fund.

3. After the Rooppur nuclear reactor was put into operation, which nation moved up to number 33 on the global nuclear power production list?

Bangladesh received the first batch of uranium from Russia for its Rooppur Nuclear Power Plant (RNPP).

The Director General of Rosatom, Aleksey Likhachev, handed over the nuclear fuel during a function presided over by Bangladesh's Science and Technology Minister, Architect Yeafesh Osman.

A second shipment of uranium, which is the nuclear fuel for the first unit of the Rooppur Nuclear Power Plant, arrived in Dhaka on a special plane at Dhaka Shahjalal International Airport.

The Rooppur Nuclear Power Plant, with a capacity of **2400 MW**, is being built by Rosatom, a Russian contractor.

It consists of two units, each capable of producing 1200 MW of electricity.

The nuclear fuel is expected to produce power for one year before reloading is required.

Russia has committed to taking back the spent fuel from the Rooppur Plant to their country.

## Answer: A

Indonesian President Joko Widodo inaugurated Southeast Asia's first high-speed railway connecting Jakarta and Bandung, a project under China's Belt and Road initiative. The project, with a budget of \$7.3 billion,

largely funded by China, aims to reduce travel time between Jakarta and Bandung from 3 hours to just 40 minutes.

The high-speed railway is expected to **reduce carbon emissions** and promote efficient mass transportation.

President Widodo named the railway "Whoosh," which stands for 'Waktu Hemat, Operasi Optimal, Sistem Handal,' emphasizing its modernization and environmental benefits.

The rail deal was signed in October **2015**, with China Development Bank providing 75% of the financing through a loan, and the remaining 25% came from the consortium's funds.

The project is part of a larger plan to build a 750-kilometre (466-mile) high-speed train line across 4 provinces on Indonesia's main island of Java, ultimately connecting to Surabaya, the **2nd-largest city** in the country.

Despite disputes, the project aims to transfer technology to Indonesia, potentially supporting future domestic high-speed train production. 5. Recently (Oct 2023), Which government, except the Forest Department, has established a 35% reservation for women in all government job recruitments?

The reservation for women is to be applied **horizontally and compartment-wise**, meaning that 35% of the posts in the state's services (excluding the Forest Department) will be reserved for women at the stage of direct recruitment.

Chief Minister Shivraj Singh Chouhan declared that 35% of vacancies in the police and other government job positions will be filled by women.

Additionally, the government has also reserved **50%** of teaching positions for women.

Previous Initiatives: Madhya Pradesh had previously implemented 50% reservation for women in the elections of **Panchayats** and **urban bodies**.

The state offers concessional fees for property registration if the property is registered in the name of a woman.

Out of a total of 5 crore 60 lakh voters in MP, 2 crores 72 lakhs are women voters.

Horizontal reservation is a concept **aimed** at providing equal opportunities to various categories of beneficiaries, such as women, veterans, the transgender community, and individuals with disabilities, across different segments or compartments of government job positions.

It ensures that these categories have a fair and equitable chance to secure employment, cutting through the vertical categories.

This approach aligns with the constitutional principle of equal opportunity and is **exemplified by Article 15(3) of the Constitution.** 

"Compartment-wise" refers to a strategy that divides or categorizes different aspects or components of the program into separate compartments or segments.

Each compartment may have its own set of rules, objectives, or criteria.

In the case of Madhya Pradesh's new policy, "compartment-wise" reservation means that the 35% quota for women will be applied in a manner that considers different departments or sectors separately, ensuring that women have access to a diverse range of government job opportunities.

He accelerated the transfer of financial assistance to beneficiaries under the "Ladli Bahna Yojana," a flagship welfare program for women.

Under this scheme, eligible beneficiaries receive **₹1,250 per month** from the state government.

This decision also closely follows the passage of the **'Women's Reservation Bill'** in Parliament, which received the assent of President Droupadi Murmu.

The 'Nari Shakti Vandan Adhniyam,' mandating 33% reservation for women in the Lok Sabha and state legislative assemblies, was unanimously passed, marking it as the first bill enacted in the new Parliament building.

In a significant milestone for the northeastern state of Arunachal Pradesh, the unique and culturally significant yak milk product, 'Yak Churpi,' has been granted the coveted Geographical Indication (GI) tag.

Yak Churpi is a dairy product made from the milk of the indigenous Arunachali yak breed.

It is reared by tribal yak pastoralists known as Brokpas who migrate along with their yaks to higher reaches (at an altitude of 10,000 ft and higher) during summers and descent to midaltitude mountainous regions during winters.

These remarkable yaks are primarily found in the West Kameng and Tawang districts of the state.

Churpi is a **naturally fermented dairy product** and is rich in protein content.

It is an essential dietary staple for tribal communities inhabiting the cold and mountainous regions of Arunachal Pradesh.

It is often used as a vegetable substitute and is also incorporated into vegetable and meat curries and is commonly consumed with rice.

Yaks are reared in high-altitude areas in the Himalayan region but the Arunachali yaks are a unique breed concerning their body shape, size, strain and weight.

They are the only registered yak breed in India.

7. Who laid the foundation stone for the largest pumped storage project in India which

Madhya Pradesh (MP) Chief Minister (CM) Shivraj Singh Chouhan laid the foundation stone for the largest pumped storage project in India, located in the Khemla block, Neemuch district, Madhya Pradesh.

The project is being developed by the **Greenko Group**, which is recognized as India's largest energy storage company.

Initially, the project had a capacity of **1440** megawatts (MW) with storage for 7.5 hours.

However, it is now being expanded to 1920 MW with storage for 6 hours.

The expansion is aimed at providing storage of nearly **11 Gigawatt hours (GWh) daily**, emphasizing the significance of energy storage.

The overall investment for the project is estimated to be Rs 11,500 crores over the next 3 years, highlighting its substantial financial commitment.

The project is scheduled to be completed within 30 months, which is faster than the allocated period of 36 months, indicating efficiency in its execution.

The project involves the construction of a new off-stream reservoir, known as the upper reservoir while utilizing the existing Gandhi Sagar Reservoir as the lower reservoir.

A cloudburst over Lhonak Lake in north Sikkim led to flash floods in the Teesta River basin.

At least 7 people have died and scores more were injured or missing after flash floods inundated Sikkim.

The Sikkim State Disaster Management Authority (SSDMA) reported that over 2,011 people have been rescued from the affected areas.

22 Army soldiers are missing following the flash floods, and there are concerns about more than 3,000 tourists being stranded in various parts of the state.

Lhonak Lake is situated in the northwest of the state at 17000 feet.

The cloud burst brought incessant rains.

Approximately half of the area of South Lhonak Lake in Sikkim was drained out due to the cloudburst, leading to water entering lowlying areas.

The increased water levels in the Teesta River caused flooding in 4 districts, including **Mangan, Gangtok, Pakyong, and Namchi.** 

The flood situation in Sikkim worsened after water was released from the Chungthang dam.

A cloudburst is defined as **sudden and very** heavy rainfall occurring in a short period.

**Integration with NPS**: The GPS will ensure pension under the NPS, which was made available for all citizens between 18-60 years of age in 2009. **NPS Investment Returns:** Currently, NPS investments offer returns ranging from 9-12% per annum along with tax benefits.

**Employee Contributions:** Government employees under GPS are required to make monthly contributions based on their basic salary and dearness allowance.

Delhi (2.7%), Gujarat (2.8%), West Bengal (4.4%), and Bihar (6.1%) are states/UTs which recorded a lower than national average unemployment rate.

The key labour market indicators are Labour Force Participation Rate (LFPR), Worker Population Ratio (WPR) and unemployment rates.

All key indicators improved in urban areas in the April-June quarter for persons aged 15 years and above compared to the prepandemic period.

**LFPR during April-June 2023 was 48.8%.** This is higher than the LFPR observed in the quarters covered in the pre-pandemic period.

The WHO has established a roadmap for 2021-2030 that sets global targets and milestones for the prevention, control, elimination, or eradication of 20 diseases, including lymphatic filariasis.

Global Programme to Eliminate Lymphatic Filariasis (GPELF): WHO established this to stop the transmission of infection by mass drug administration (MDA) of anthelmintics and to alleviate the suffering of people affected by the disease through morbidity management and disability prevention (MMDP).

According to the WHO progress report, a total of 19 countries have successfully eliminated lymphatic filariasis.

Among them, **11 countries** belong to the WHO Western Pacific Region (WPR), and Lao PDR is the 11th country in this region to eliminate LF.
