Such words on the cigarette packs should warn the smokers beforehand of its adverse effects. So, argument I holds strong. However, smoking is a bad habit with long term health hazards and is no means of enjoyment. Also, the graphic







depiction aims at deterring smokers to purchase cigarettes, hence argument II does not apply.

#### 136) Answer: A

The correct answer is option a, i.e. In addition to rising delinquencies over the last few years would force lenders to be more cautious while underwriting loans. This would limit refinancing options, adversely affecting existing borrowers.

- B). This answer fails to make a connection between the proposed law and extending life expectancy.
- C). This answer provides no direct evidence to strengthen the link between removing second-hand smoke via legislation and lengthening lifespan.
- D). The evidence that passing a similar law reduced cancer rates supports the legislators' case that banning smoking in many places will promote "length of lifespan" (i.e., with people dying of cancer less, they live longer)
